

## **IMPORTANT SAFETY RECALL**

Dear Grand Design RV Owner:

This notice is sent to you in accordance with the requirements of the *Canadian Motor Vehicle Safety Act.* This is to inform you that your vehicle may contain a defect that could affect the safety of a person.

Grand Design has decided a safety defect exists in certain model years **2022** through **2024 Grand Design Momentum 23G & 25G** travel trailers equipped with incorrect safety chains. Accordingly, a recall to address this issue is being initiated effective **September 6, 2023**.

## **! IMPORTANT !**

- > Your vehicle falls within the recall population.
- You should immediately schedule an appointment with your dealer to have your vehicle repaired.

## Why is a recall being conducted?

The defect involves certain 2022-2024 Momentum Travel Trailers equipped with 11,700-pound safety chains. The safety chains are underrated for the GVWR of the trailer. Should the trailer become uncoupled from the tow vehicle, the safety chains could break. This could lead to a loss of control, increasing the risk of a crash.

What are we doing about the problem?	Grand Design RV will notify owners by mail and advise you take your trailer to a dealership to replace the safety chains. Grand Design will supply to your dealer, the necessary items to complete the repair or replace the incorrect part. Time for repair is approximately 1 hour. These repairs will be done free of charge.
What should you do?	Contact your selling or nearest Grand Design RV dealer as soon as possible to schedule an appointment. If your distance from a Grand Design dealer is significant, please contact us at 574-825-9679 and choose the "Recall" prompt or email <u>recall@granddesignrv.com</u> We can discuss other arrangements to have the needed repairs completed.
What if I no longer own this recreational vehicle?	Notify Grand Design either by phone: 574-825-9679, fax: 574-825-9249, or email: <u>registration@granddesignrv.com</u> to inform us that you no longer own this vehicle. Please be sure to include your 17-digit VIN in all correspondence.

**If you are the lessor of this vehicle**, please forward a copy of this notice to the lessee within ten days to comply with federal regulations.

If you have already paid to have your vehicle repaired for this condition, you may be eligible for reimbursement of the charges you paid for the repair.
